Video Requirements

1. The person submitting the video must also be performing in the video
2. The video must not be more than 1 1/2 minutes long.
3. The video must comply with YouTube Terms of Use (<http://www.youtube.com/t/terms>)
4. The video must be a new video uploaded to the BaliYo YouTube Channel or to BaliYo's page on facebook on or after 01-Apr-2010 and no later than 02-May-2010.

5. The performer in the video must be performing with a BaliYo only, nothing else.
6. The video must not contain any copyrighted works (unless you own the copyright), anything in the video must be entirely original and created and performed by you.
7. Inappropriate or offensive videos will be disqualified and removed from the contest group.

Determination of Winners

The winning video will be chosen by Spyderco by meeting the following criteria:

1. Creativity
2. How well your video fits with the Video Requirements outlined above.
3. Winners will be announced the week of 03-May-2010 and contacted through YouTube, Facebook or e-mail.
4. All submitted videos will be embedded on our various websites.

Prizes

The top three videos will be chosen by Spyderco and awarded a Visa gift card. First Place, \$500 (USD). Second Place, \$250 (USD). Third Place, \$125 (USD).
